	<ul style="list-style-type: none"> <li>▶ Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids.</li> <li>▶ Seek medical attention without delay; if pain persists or recurs seek medical attention.</li> <li>▶ Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.</li> </ul>
<b>Skin Contact</b>	<p>If skin or hair contact occurs:</p> <ul style="list-style-type: none"> <li>▶ Flush skin and hair with running water (and soap if available).</li> <li>▶ Seek medical attention in event of irritation.</li> </ul>
<b>Inhalation</b>	<ul style="list-style-type: none"> <li>▶ If fumes or combustion products are inhaled remove from contaminated area.</li> <li>▶ Lay patient down. As in all cases of suspected poisoning, follow the ABCDEs of emergency medicine (airway, breathing, circulation, disability, exposure), then the ABCDEs of toxicology (antidotes, basics, change absorption, change distribution, change elimination).

**BASIC TREATMENT**  
 -----

- ▶ Establish a patent airway with suction where necessary.
- ▶ Watch for signs of respiratory insufficiency and assist ventilation as necessary.
- ▶ Administer oxygen by non-rebreather mask at 10 to 15 L/min.
- ▶ Monitor and treat, where necessary, for pulmonary oedema.
- ▶ Monitor and treat, where necessary, for shock.
- ▶ Anticipate seizures.
- ▶ **DO NOT** use emetics. Where ingestion is suspected rinse mouth and give up to 200 ml water (5 ml/kg recommended) for dilution where patient is able to swallow, has a strong gag reflex and does not drool.

**ADVANCED TREATMENT**  
 -----

- ▶ Consider orotracheal or nasotracheal intubation for airway control in unconscious patient or where respiratory arrest has occurred.
- ▶ Positive-pressure ventilation using a bag-valve mask might be of use.
- ▶ Monitor and treat, where necessary, for arrhythmias.
- ▶ Start an IV D5W TKO. If signs of hypovolaemia are present use lactated Ringers solution. Fluid overload might create complications.
- ▶ Drug therapy should be considered for pulmonary oedema.
- ▶ Hypotension with signs of hypovolaemia requires the cautious administration of fluids. Fluid overload might create complications.
- ▶ Treat seizures with diazepam.
- ▶ Proparacaine hydrochloride should be used to assist eye irrigation.

<b>Fire/Explosion Hazard</b>	<ul style="list-style-type: none"> <li>▶ Solid which exhibits difficult combustion or is difficult to ignite.</li> <li>▶ Avoid generating dust, particularly clouds of dust in a confined or unventilated space as dusts may form an explosive mixture with air, and any source of ignition, i.e. flame or spark, will cause fire or explosion.</li> <li>▶ Dust clouds generated by the fine grinding of the solid are a particular hazard; accumulations of fine dust (420 micron or less) may burn rapidly and fiercely if ignited; once initiated larger particles up to 1400 microns diameter will contribute to the propagation of an explosion.</li> <li>▶ A dust explosion may release large quantities of gaseous products; this in turn creates a subsequent pressure rise of explosive force capable of damaging plant and buildings and injuring people.</li> <li>▶ Usually the initial or primary explosion takes place in a confined space such as plant or machinery, and can be of sufficient force to damage or rupture the plant. If the shock wave from the primary explosion enters the surrounding area, it will disturb any settled dust layers, forming a second dust cloud, and often initiate a much larger secondary explosion. All large scale explosions have resulted from chain reactions of this type.</li> <li>▶ Dry dust can also be charged electrostatically by turbulence, pneumatic transport, pouring, in exhaust ducts and during transport.</li> <li>▶ Build-up of electrostatic charge may be prevented by bonding and grounding.</li> <li>▶ Powder handling equipment such as dust collectors, dryers and mills may require additional protection measures such as explosion venting.</li> <li>▶ All movable parts coming in contact with this material should have a speed of less than 1-metre/sec.</li> </ul> <p>Decomposition may produce toxic fumes of: carbon monoxide (CO) carbon dioxide (CO<sub>2</sub>) other pyrolysis products typical of burning organic material. <b>Minor Spills</b>	<ul style="list-style-type: none"> <li>▶ Clean up waste regularly and abnormal spills immediately.</li> <li>▶ Avoid breathing dust and contact with skin and eyes.</li> <li>▶ Wear protective clothing, gloves, safety glasses and dust respirator.</li> <li>▶ Use dry clean up procedures and avoid generating dust.</li> <li>▶ Vacuum up or sweep up. <b>NOTE:</b> Vacuum cleaner must be fitted with an exhaust micro filter (H-Class HEPA type) (consider explosion-proof machines designed to be grounded during storage and use). H-Class HEPA filtered industrial vacuum cleaners should <b>NOT</b> be used on wet materials or surfaces.</li> <li>▶ Dampen with water to prevent dusting before sweeping.</li> <li>▶ Place in suitable containers for disposal.</li> </ul>

	<ul style="list-style-type: none"> <li>▶ Work clothes should be laundered separately. Launder contaminated clothing before re-use.</li> <li>▶ Use good occupational work practice.</li> <li>▶ Observe manufacturer's storage and handling recommendations contained within this SDS.</li> <li>▶ Atmosphere should be regularly checked against established exposure standards to ensure safe working conditions are maintained.</li> <li>▶ Organic powders when finely divided over a range of concentrations regardless of particulate size or shape and suspended in air or some other oxidizing medium may form explosive dust-air mixtures and result in a fire or dust explosion (including secondary explosions)</li> <li>▶ Minimise airborne dust and eliminate all ignition sources. Keep away from heat, hot surfaces, sparks, and flame.</li> <li>▶ Establish good housekeeping practices.</li> <li>▶ Remove dust accumulations on a regular basis by vacuuming or gentle sweeping to avoid creating dust clouds.</li> <li>▶ Use continuous suction at points of dust generation to capture and minimise the accumulation of dusts. Particular attention should be given to overhead and hidden horizontal surfaces to minimise the probability of a "secondary" explosion. According to NFPA Standard 654, dust layers 1/32 in.(0.8 mm) thick can be sufficient to warrant immediate cleaning of the area.</li> <li>▶ Do not use air hoses for cleaning.</li> <li>▶ Minimise dry sweeping to avoid generation of dust clouds. Vacuum dust-accumulating surfaces and remove to a chemical disposal area. Vacuums with explosion-proof motors should be used.</li> <li>▶ Control sources of static electricity. Dusts or their packages may accumulate static charges, and static discharge can be a source of ignition.</li> <li>▶ Solids handling systems must be designed in accordance with applicable standards (e.g. NFPA including 654 and 77) and other national guidance.</li> <li>▶ Do not empty directly into flammable solvents or in the presence of flammable vapors.</li> <li>▶ The operator, the packaging container and all equipment must be grounded with electrical bonding and grounding systems. Plastic bags and plastics cannot be grounded, and antistatic bags do not completely protect against development of static charges.</li> </ul> <p>Empty containers may contain residual dust which has the potential to accumulate following settling. <b>Notes:</b>	<i>Occupational exposure banding is a process of assigning chemicals into specific categories or bands based on a chemical's potency and the adverse health outcomes associated with exposure. The output of this process is an occupational exposure band (OEB), which corresponds to a range of exposure concentrations that are expected to protect worker health.</i>	

**Exposure controls**

	<p><b>For potent pharmacological agents:</b></p> <p><b>Powders</b></p> <p>To prevent contamination and overexposure, no open handling of powder should be allowed.</p> <ul style="list-style-type: none"> <li>▶ Powder handling operations are to be done in a powders weighing hood, a glove box, or other equivalent ventilated containment system.</li> <li>▶ In situations where these ventilated containment hoods have not been installed, a non-ventilated enclosed containment hood should be used.</li> <li>▶ Pending changes resulting from additional air monitoring data, up to 300 mg can be handled outside of an enclosure provided that no grinding, crushing or other dust-generating process occurs.</li> <li>▶ An air-purifying respirator should be worn by all personnel in the immediate area in cases where non-ventilated containment is used, where significant amounts of material (e.g., more than 2 grams) are used, or where the material may become airborne (as through grinding, etc.).</li> <li>▶ Powder should be put into solution or a closed or covered container after handling.</li> <li>▶ If using a ventilated enclosure that has not been validated, wear a half-mask respirator equipped with HEPA cartridges until the enclosure is validated for use.</li> </ul> <p><b>Solutions Handling:</b></p> <ul style="list-style-type: none"> <li>▶ Solutions can be handled outside a containment system or without local exhaust ventilation during procedures with no potential for aerosolisation. If the procedures have a potential for aerosolisation, an air-purifying respirator is to be worn by all personnel in the immediate area.</li> <li>▶ Solutions used for procedures where aerosolisation may occur (e.g., vortexing, pumping) are to be handled within a containment system or with local exhaust ventilation.</li> <li>▶ In situations where this is not feasible (may include animal dosing), an air-purifying respirator is to be worn by all personnel in the immediate area. If using a ventilated enclosure that has not been validated, wear a half-mask respirator equipped with HEPA cartridges until the enclosure is validated for use.</li> <li>▶ Ensure gloves are protective against solvents in use.</li> </ul> <p><b>Unless written procedures, specific to the workplace are available, the following is intended as a guide:</b></p> <ul style="list-style-type: none"> <li>▶ <b>For Laboratory-scale handling of Substances assessed to be toxic by inhalation. Quantities of up to 25 grams</b> may be handled in Class II biological safety cabinets*; <b>Quantities of 25 grams to 1 kilogram</b> may be handled in Class II biological safety cabinets* or equivalent containment systems; <b>Quantities exceeding 1 kg</b> may be handled either using specific containment, a hood or Class II biological safety cabinet*.</li> <li>▶ HEPA terminated local exhaust ventilation should be considered at point of generation of dust, fumes or vapours.</li> <li>▶ The need for respiratory protection should also be assessed where incidental or accidental exposure is anticipated. Dependent on levels of contamination, PAPR, full face air purifying devices with P2 or P3 filters or air supplied respirators should be evaluated. When handling: <b>Quantities of up to 25 grams</b>, an approved respirator with HEPA filters or cartridges should be considered; <b>Quantities of 25 grams to 1 kilogram</b>, a half-face negative pressure, full negative pressure, or powered helmet-type air purifying respirator should be considered. <b>Quantities in excess of 1 kilogram</b>, a full face negative pressure, helmet-type air purifying, or supplied air respirator should be considered.</li> </ul> <p>Written procedures, specific to a particular work-place, may replace these recommendations</p> <p>* For Class II Biological Safety Cabinets, Types B2 or B3 should be considered. Where only Class I, open fronted Cabinets are available, glove panels may be added, Laminar flow cabinets do not provide sufficient protection when handling these materials unless especially designed to do so.</p> <p><b>Pilot Plant and Production</b></p> <ul style="list-style-type: none"> <li>▶ Wear appropriate gloves; lab coat, nylon coveralls or disposable Tyvek suit; safety glasses, safety shoes, and disposable booties. [AS/NZS 1337.1, EN166 or national equivalent]</li> <li>▶ Face shield. Full face shield may be required for supplementary but never for primary protection of eyes.</li> <li>▶ Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. A written policy document, describing the wearing of lenses or restrictions on use, should be created for each workplace or task. ### Information on toxicological effects

<b>MONENSIN SODIUM</b>	<p>Spastic paralysis, muscle weakness, ataxia, diarrhoea recorded.</p> <p>The following information refers to contact allergens as a group and may not be specific to this product. Contact allergies quickly manifest themselves as contact eczema, more rarely as urticaria or Quincke's oedema. The pathogenesis of contact eczema involves a cell-mediated (T lymphocytes) immune reaction of the delayed type. Other allergic skin reactions, e.g. contact urticaria, involve antibody-mediated immune reactions. The significance of the contact allergen is not simply determined by its sensitisation potential: the distribution of the substance and the opportunities for contact with it are equally important. A weakly sensitising substance which is widely distributed can be a more important allergen than one with stronger sensitising potential with which few individuals come into contact. From a clinical point of view, substances are noteworthy if they produce an allergic test reaction in more than 1% of the persons tested.</p> <p>Oxidative stress appears to be a common feature of ionophores as both monensin and salinomycin were reported to increase the production of reactive oxygen species (ROS). Cells respond to oxidative stress by upregulating ROS detoxifying pathways, and nicotinamide adenine dinucleotide phosphate (NADPH) is a crucial coenzyme that is required for the regeneration of reduced glutathione that is used to detoxify ROS. AMP-activated protein kinase (AMPK) was shown to increase NADPH production via enhancing glycolytic flux.</p> <p>In addition, oxidative stress by ionophores damages DNA. Cells use the enzyme poly (ADP-ribose) polymerase (PARP) to signal damaged DNA by catalyzing the addition of ADP-ribose moieties to nuclear proteins at the site of damage in a reaction that consumes NAD<sup>+</sup>. In the case of extensive DNA damage, PARP can become overstimulated and deplete cellular NAD<sup>+</sup>. Glycolysis depends upon the reduction of NAD<sup>+</sup> to NADH, and loss of NAD<sup>+</sup> blocks glycolysis.</p>

	<p>Loss of glycolysis impairs NADPH production and rapidly depletes ATP, ultimately leading to necrotic cell death. This mechanism of bioenergetics catastrophe leading to necrosis has been reported for DNA damaging alkylating agents (e.g. nitrogen mustards Myocardial Na<sup>+</sup>/H<sup>+</sup>exchanger (NHE) is represented primarily by the ubiquitous NHE-1 subtype which is expressed in most tissues. The robust positive results seen with NHE-1 inhibitors in experimental studies have led to relatively rapid development of these pharmacological agents for clinical assessment especially as potential cardioprotective therapies. Whether this response is justified is open for discussion although a close scrutiny of clinical trial outcomes suggests that it may not be and that NHE-1 inhibition, if applied appropriately continues to represent an effective, if not the most effective approach for myocardial salvage following ischemic insult.</p> <p>Side effects of NHE3 inhibitors include dehydration (which can be serious in the old or the young), diarrhea, bloating, flatulence, abnormal bowel sounds, low blood pressure, and dizziness.</p>
<b>CALCIUM CARBONATE</b>	<p>No evidence of carcinogenic properties. No evidence of mutagenic or teratogenic effects.</p> <p>Asthma-like symptoms may continue for months or even years after exposure to the material ends. This may be due to a non-allergic condition known as reactive airways dysfunction syndrome (RADS) which can occur after exposure to high levels of highly irritating compound. Repeated or prolonged exposure to irritants may produce conjunctivitis.</p> <p>The material may cause skin irritation after prolonged or repeated exposure and may produce on contact skin redness, swelling, the production of vesicles, scaling and thickening of the skin.</p>
